The puppy described above is warranted to be healthy and free of any communicable disease for a period of five (5) Business days from date of receiving (excluding Giardia). With a visit to and verification by a licensed veterinarian of the buyer's choice and at buyer's expense within five business days of purchase. If the above puppy should be found within five days after purchase to have a communicable disease which renders it unfit as a pet, the puppy will be replaced or a full refund of purchase price of puppy will be given. Replacement and/or refund shall be conditional upon receipt of a signed veterinarian's certificate, stating clearly the disease responsible for such condition. The buyer shall be responsible for all shipping costs associated with shipping the replacement puppy if buyer decides he or she wants a replacement puppy.

Your puppy will need to be picked up within 1 week after puppy turns 8 weeks old unless arranged otherwise by A&R Country Kennels .Deposit is non refundable and non transferable unless puppy is unfit. The breeder will not accept any returns of said puppy for any monetary refund, including but not limited to allergy, landlord/tenant ,marital, or adjustment problems, etc. If the buyer must return the puppy for any reason, it will be on a surrender basis only with no refund or credit, and the buyer will be responsible for all shipping costs.

**LIMITED WARRANTY** that within a one (1) year period following date of birth, seller warrants the purchased puppy against any genetic defect which would render the puppy unfit as a pet. In the event that a defect in the puppy is discovered within such period and is verified by a licensed veterinarian pursuant to examination to be truly genetic and not environmentally caused, seller shall have the option to refund all of the purchase price or to furnish buyer with a replacement puppy of similar quality and value at seller's convenience. This warranty is for limited breeding Rights only.

**DISCLAIMER OF WARRANTIES.** The puppy sold in this agreement is being sold "AS IS" and the seller disclaims all warranties of quality, whether express OR implied, including the warranties of merchantability and fitness for any particular purpose other than the limited warranties set forth above.

The puppy above is sold as a "Family Companion" only, with no other warranties, promises or guaranties for breeding, showing or any other purpose other than as a pet. Limited warranty described above constitutes the complete warranty between seller(A&R Country Kennels) and the buyer and no other representations, promises or warranties apply whether stated or implied

The parties agree that the seller shall not be responsible OR liable for any incidental OR consequential damages including any veterinary examination or treatment and that sellers' liability, regardless of theory, shall be limited in all circumstances to an amount not to exceed the purchase price paid for the puppy.
